FILING INSTRUCTIONS FOR THE FILING OF MINOR ADOPTION (STEP PARENT OR FOSTER PARENT ADOPTION)

Please Note: Representation by an attorney is mandatory for all petitioners

In addition to the standard probate forms necessary to file a Petition for Adoption of Minor, the following must also be provided *at the time of filing*:

- Filing fees of \$150.00 (additional costs may be required as this is a cost deposit ONLY)
- *Home study fees of \$500.00 payable by a separate check or money order. Please call the court for updated information on the adoption assessor and who to write the check to. If more than one is child to be adopted, each additional home study will be \$100.00 (In some cases home study fees may be waived in a foster parent petition if the county agency placed the children – check with the deputy clerk before filing)
- BCI and FBI background check results for each petitioner and each adult living in the adoptive home. These must be filed with the petition.
- Certified copy of the child's birth certificate
- Putative Father Certificate if the father's name is NOT on the birth certificate unless the exceptions in ORC 3107.064(B) are applicable
- Statement of Adopted Person

The following is required at least seven (7) days prior to the hearing:

- All proposed orders
- Certificate of Adoption (HEA 2757) required for all Ohio births
